Case Study

MedscapeCME developed, certified and measured a CME Resource Center focused on patient safety, in collaboration with FDA Medwatch and ISMP.

Educational Needs and Development: The Institute of Medicine (IOM) reports US clinicians commonly fail to address risks of adverse events with patients, and to effectively report the events. To bridge the gap, many have recommended changes to training on adverse events. To address this need, PhRMA awarded an independent educational grant to MedscapeCME to develop a CME/CE curriculum. One of the activities, "Communicating Drug Risks to Patients" was developed for Physicians: 1 AMA PRA Category 1 Credit(s)TM of CME, and accredited for Nurses, and Pharmacists.

Outcomes Results: Participants in Communicating Drug Risks to Patients are 44% more likely to use recommended safety measures of:

- Providing drug information both verbally and in writing
- Using open ended questions to assess attitudes and understanding of medications
- Discussing with patients consequences of non-compliance

Clinical Significance: An estimated 868,000 patients seen each week will benefit from improved care provided by the 14,320 healthcare providers who have participated in this MedscapeCME activity through April 2009.
